Documents required to be uploaded for an individual to be approved as a user of CANS:

How to upload documents: First, insert the documents face-down in the scanner. If you have a flatbed scanner, make sure that it is clean and free of debris. Second, press the “Scan” button. Wait for the document to scan. After the final scan is completed, you can save the document by clicking on “File” and then “Save”. Next, click on “Browse”. Then, find and select the file you want to upload. Finally, click on “Upload File”.
